- 5. Public Comments Jennifer Kriegh complimented the communication between school, parents and students during remote learning. Mr. Washington of CCEM inquired about a letter of support for rewriting the Hazard Management Plan. Dr. Brown of CCDPH said that 2013 was the last year of the County's 5-year Plan and would welcome any comments for what's been done right or wrong or any suggestions & positive steps to help write the 2020 5-year Plan. Dr. Davis asked for a Liaison from the School Board to help with the new 5-Year plan; Doreen volunteered.
